^{*}A critical element of professional policing is ensuring the response to resistance we use is appropriate, legal, within policy, reviewed for improvement and enhanced training and supervised. Below is an abbreviated summary of the instances of our response to resistance to arrest:

Officers investigated the report of theft of services after a taxi did not receive payment for a fare. It was determined to be a subject with chronic mental health problems, which officers have frequent contact with. The suspect, who was contacted on the scene, attempted to flee on foot. Officers grabbed the suspect and took him to the ground. After several commands, the suspect refused to place his hands behind his back. An officer was able to use a knee strike to free the suspect's arm from under his body. He was subsequently handcuffed and had no injuries.

Officers responded to a fight in progress at the intersection of St. Clair Road and Old Lincoln Trail. Upon arrival, two suspects fled the scene on foot. An officer gave chase and gave the suspects commands to stop. He removed his department-issued taser and provided a verbal warning. The subjects complied and were taken into custody. The Taser was not activated.

An officer responded to DXL for a report of a person slumped behind the wheel in the parking lot. Upon arrival, the officer observed the subject to have an intravenous need sticking of her arm. He woke up the subject and asked her to exit the vehicle. She slightly resisted being placed in handcuffs by not putting her hands behind her back. The officer pressed her against the vehicle and was able to gain control of her arms, placing her in handcuffs. The subject later claimed the officer slammed her head multiple times against her car. A review of body camera revealed her claim was unfounded.

Officers responded to TJ Maxx for an alarm. While on scene, a garbage man summoned the officers, explaining the business next door, Drip Nation, was being burglarized. Officers responded to the scene and observed a vehicle waiting outside. They removed their department issued firearms and pointed them at the suspect vehicle while attempting to gain compliance by way of felony traffic stop procedures. Additional subjects exited the store, entered the vehicle, which fled from the scene. Officer pursued but discontinued when the dangerous manner in which the suspects drove outweighed the possibility of a safe outcome.

Officers arrested a mentally ill subject at Planet Fitness for criminal trespass. The subject resisted arrest and was transported to the police department. Officers escorted the subject into the jail where he was unhandcuffed at the entrance to the jail cell. The subject turned around and attempted to strike one of the officers with his fist. The officer entered the cell, obtained double wrist control, and pushed him onto the bench until he calmed down. He was subsequently released from the officer's hold. He was charged with a felony and detained for a mental health evaluation by the court system.

Officers responded to French Village Industrial Drive for a burglar alarm. They discovered a broken window to the business. One officer assumed a cover position by removing his department-issued firearm and another assumed the primary position by removing his department-issued taser. They discovered a subject within the building and gave him verbal commands to exit. The subject complied with verbal instructions and was taken into custody without injuries.

An officer conducted a vehicle stop on a reported stolen vehicle. He assumed felony traffic stop procedures and removed his duty-issued firearm from the holster. The occupants complied with verbal instructions and were taken into custody without injuries.

Officers responded to Old Lincoln Trail for a domestic disturbance. Upon arrival, they observed a male chasing a female down the street. The male subject refused to follow the officers' directions on scene to stop approaching the female. As a result, one officer displayed her taser toward the subject while the other officer conducted a leg sweep, knocking the male suspect to the ground. The subject was subsequently handcuffed and taken into custody without injuries.
